E-voting Information

In terms of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 thereto, as amended, and Regulation 44 of the SEBI Listing Regulations, the Company is providing the remote e-voting facility to its members to cast their vote by electronic means (Remote e-voting) on all the resolutions set forth in the Notice. The Company has engaged services of Central Depository Services Limited (CDSL) for providing e-voting facility. Kindly refer the Notice regarding instructions on e-voting. The Notice of the Annual General Meeting is also available on the website of the Company i.e. www.thepoojagroup.com. and website of CDSL viz. www.cdslindia.com.

Remote e-voting shall commence from September 23, 2016 (9.00 A.M) and end on September 25, 2016 (5.00 P.M). The Remote e-voting module shall be disabled by CDSL after 5.00 P.M. on September 25, 2016. The cut –off date for determining the eligibility to vote is September 19, 2016 and only the persons holding shares of the Company (in physical or dematerialized form) on the cut-off date shall be entitled to avail the facility of Remote e-voting/voting through ballot or voting through ballot at the AGM. Any person who acquires shares of the Company and becomes a Member of the Company after the dispatch of Notice and hold shares on the cut-off date of September 19, 2016, should follow the instructions given in Notice to obtain his/her login id and password for Remote e-voting. In case members cast their vote both by physical ballot and Remote e-voting, then voting done through Remote e-voting shall prevail and voting done by physical ballot will be treated as invalid. Members who have neither voted through Remote e-voting facility nor through ballot, will be permitted to deposit the filled in ballot forms physically at the AGM to enable them to exercise their vote. The Members who have already casted their vote through Remote e-voting/ ballot may attend the AGM but shall not be entitled to cast their vote at the AGM.
